## ACKNOWLEDGEMENT, EXPRESS ASSUMPTION OF RISK, WAIVER, RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

### Acknowledgement

I, the undersigned, have read and understand the rules and player responsibilities of Charm City Soccer League, LLC (the "League") as set forth on the League's website and amended from time to time and agree to such rules. I further acknowledge that I am in good health and able to participate in such activities.

### Express Assumption of Risk

For, and in consideration of my participation in the League, I hereby, for myself, my heirs, and personal representatives, assume any and all risk associated with my participation in the League and release and waive any and all rights and claims that I may now, or in the future, have against the Charm City Soccer League, LLC, its agents, directors, employees or subcontractors, officers, members, volunteers and affiliates (collectively the "League Representatives"), arising out of participation in the League or any related activities. I hereby fully release and discharge the League and League Representatives which are or might be liable to me from any and all claims and demands of whatever nature or in any way growing out of personal injury, property damage or loss, resulting from, sustained by me or arising out of, in connection with, or in any way associated with the activities of or my participation in the League. By entering into this Agreement, I am not relying on any oral or written representation or statements made by the League or League Representatives other than that which is set forth in this Agreement.

I acknowledge that the League is not responsible for any inclement weather or the condition of any playing field and release and waive all claims against the League and League Representatives for damage or loss that may arise therefrom. I further acknowledge that the League assumes no responsibility for medical treatment or payment of any medical bills.

I authorize the League to use photos and/or other likeness of myself for promotional materials regarding League programs, services and product offerings. Such photos and/or likeness will not be sold by the League to other parties.
